FOR IMMEDIATE RELEASE – 09/29/2023 – Denver, Co, KVK- MJM Holdings (dba Sticky Fingerz DIspensary. is voluntarily recalling one lot (Batch Number: Energize Banana Runtz 1G Cart RPB101822W, Uplift Honeydew 1G Cart RPB101822X, Chill Strawberry Soda 1G Cart RPB101822Y, Sleep Granddaddy Purple 1G Cart RPB101822Z; “the batch”) of 1000mg Cartridge, gold, round , Liquid concentrate. The batch was distributed at Sticky Fingerz retailer. The batch is being recalled as a precautionary measure due to potentially unstable products sold after expiration date. MJM Holdings has not received any reports of cartridge in any package or date (Batch Numbers Energize Banana Runtz 1G Cart RPB101822W, Uplift Honeydew 1G Cart RPB101822X, Chill Strawberry Soda 1G Cart RPB101822Y, Sleep Granddaddy Purple 1G Cart RPB101822Z) at this time.

Risk Statement:

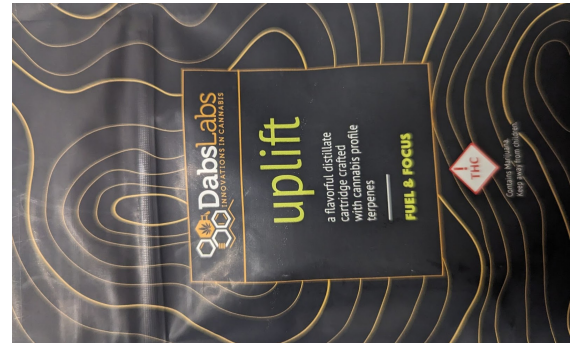

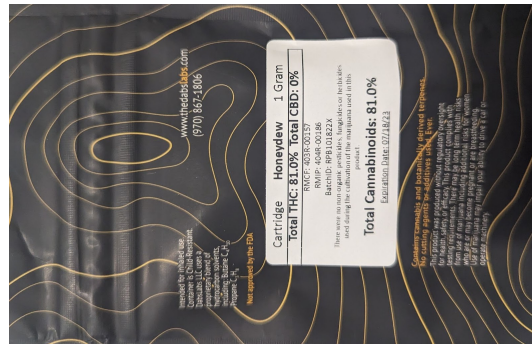
